

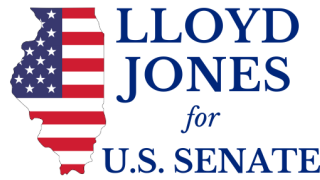


REBUILD TRUST, RESTORE ILLINOIS

Petition Circulation Instructions

Thank you for supporting Lloyd Jones' nominating petition for U.S. Senate. Circulating petitions is a vital part of the democratic process, and we're grateful for your help. Please follow the guidelines below, which reflect Illinois election law and best practices for signature collection.

Circulators Must

1. Be **U.S. citizens**.
2. Be **at least 18 years old at the time of signing** the petition.
3. **Confirm** that each signer is a **registered voter in Illinois**.
4. **Confirm** that each signer **resides in the State of Illinois**.
5. **Personally witness** each and every signature. Petitions must remain in your line of sight at all times.

Circulators Must Not

1. Circulate petitions for candidates of **any other political party** during this petition drive.
2. Allow anyone to sign who is **not registered to vote in Illinois**.
3. Allow one person to **sign for another individual**.
4. Allow someone else to **take the petition out of your sight** to collect signatures.

Signature Corrections

- If a signer makes an error, **draw a single line through the signature**.
- **Do not use correction fluid** or obscure the original writing.
- Please **do not fill in the "sheet number"** at the bottom of the page, We'll complete that during final binding.

Finalizing Your Petition Sheet

Once your petition sheet has signatures:

1. Fill out the **Circulator's Name and Address** section at the bottom.
2. Visit a **notary public**.
3. In front of the notary, **sign the petition sheet** in the space marked "Circulator's Signature."
4. The notary will complete their section and **stamp the sheet with an official seal**.

Mailing Instructions

Please mail **completed, original, signed, and notarized** petition sheets to: **Lloyd Jones for U.S. Senate**, 249 E. U.S. Route 6, #220, Morris, IL 60450. **Mail no later than October 25, 2025**. We recommend using a **trackable mailing service** to ensure timely delivery.
